TOWN OF VICTOR FEE SCHEDULE - Chapter 27 Fees, Section 27-8. Fees enumerated.

Fees for the Town of Victor shall be as follows:

A. Chapter 27, Article I, Reimbursement of Fees.

Engineering review fees to be submitted in conjunction with the application fee:

- (1) Change of use site plan approval (if applicable): \$75.00.
- (2) Commercial and industrial site plans.
 - (a) Less than five acres: \$200.00.
 - (b) More than five acres: \$700.00.
- (3) Residential site plans.
 - (a) Single-family dwelling: \$200.00.
 - (b) Two-family dwelling: \$200.00.
 - (c) Accessory structure: \$75.00.
- (4) Minor subdivisions: \$75.00 per lot.
- (5) Major subdivisions.
 - (a) Sketch plan: \$25.00 per lot.
 - (b) Preliminary plan: \$50.00 per lot.
 - (c) Final plan: \$25.00 per lot.
- (6) Solid waste management facility permit: \$1,000.00.
- (7) Flood damage permit: \$200.00.
- (8) Manufactured home parks: \$50.00 per manufactured home site.

NOTE: Engineering fees may exceed the amount set above. If engineering review exceeds the amount submitted at the time of application, the applicant will be billed on a monthly basis and receive a copy of the Town engineer's invoice.

B. Chapter 57 - Adult Entertainment.

- (1) Initial application fee: \$2,000.00.
- (2) Renewal fee: \$500.00.

C. Chapter 66 - Bingo.

(1) Fees shall be set by New York State.

D. Chapter 84 - Clearing, Grading, and Filling.

(1) Less than an acre: \$25.00.

(2) More than an acre: \$50.00.

NOTE: As provided for in Chapter 27, Art. I, Reimbursement of Fees, all administrative expenses (i.e., legal, engineering) incurred by the Town in review and processing of the applications shall be charged back to the applicant as a fee related to the application submitted.

E. Chapter 90 – Dogs.

(1) Unaltered dog (unspayed or unneutered): \$30.00 (local fee of \$27.00, surcharge of \$3.00, as mandated by the New York State Agriculture and Markets Law). **Amended 4/27/2020**

(2) Altered dog (spayed or neutered): \$20.00 (local fee of \$19.00, surcharge of \$1.00, as mandated by the New York State Agriculture and Markets Law). **Amended 4/27/2020**

(3) Senior citizens (60 years or older) shall receive a discount as follows:

(a) Unaltered dog (unspayed or unneutered): \$25.00 (local fee of \$22.00, surcharge of \$3.00, as mandated by the New York state Agriculture and Markets Law). **Amended 4/27/2020**

(b) Altered dog (spayed or neutered): \$15.00 (local fee of \$14.00, surcharge of \$1.00, as mandated by the New York state Agriculture and Markets Law). **Amended 4/27/2020**

(4) Replacement identification tag: all dogs - fee of \$3.00.

(5) Exemptions for guide, hearing, service, war, working/search, detection, police and therapy dog.

(a) Owners of guide, hearing, service, war, working search, detection, police and therapy dogs shall be exempt from the local license fees set forth in this subsection, but must pay any applicable surcharges as follows:

[1] Unaltered dog (unspayed or unneutered): surcharge of \$3.00, as mandated by the New York State Agriculture and Markets Law.

[2] Altered dog (spayed or neutered): surcharge of \$1.00, as mandated by the New York State Agriculture and Markets Law.

(b) This subsection shall not be an exemption from the replacement identification tag fee.

(6) Purebred dog licenses. New purebred licenses established after January 1, 2011, will not be issued or receive a discount. Those holding purebred licenses before December 31, 2010, shall have the option of maintaining their current purebred licenses and renewing said licenses at applicable dates, as required:

(a) Fees for purebred dog licenses shall consist of a local fee and surcharges as follows:

[1] Local fees:

- [a] Up to 10 dogs: \$35.00 fee.
- [b] Eleven to 25 dogs: \$60.00 fee.
- [c] Twenty-Six and up dogs: \$110.00 fee.

(b) Surcharges:

- [1] Unaltered dog (unspayed or unneutered): surcharge of \$3.00, as mandated by the New York State Agriculture and Markets Law, per dog.
- [2] Altered dog (spayed or neutered): surcharge of \$1.00, as mandated by the New York State Agriculture and Markets Law, per dog.

(7) During an enumeration, any dog found to be unlicensed shall be assessed an additional surcharge of \$5.00.

(a) A sewer rent fee of \$87.50 per quarter per Commercial property unit, and \$90.00 per quarter per Residential property unit according to the property unit designations set forth at § 162-102; and **Amended 1/24/2022**

(b) A hookup and connection fee of \$1,900.00 upon hookup and connection to the sewer system.
