COMPLETENESS OF FINAL GENERIC ENVIRONMENTAL IMPACT STATEMENT WITH REGARD TO THE ADOPTION OF THE TOWN OF VICTOR COMPREHENSIVE PLAN AND AGRICULTURAL AND FARMLAND PROTECTION PLAN

On motion of Councilman Crowley, seconded by Councilman Palermo, the following resolution was

WHEREAS, the Town Board (the "Town Board") of the Town of Victor (the "Town") has identified the need to update the Comprehensive Plan as a result of the Town of Victor's growth and change since the adoption of the 1995 Comprehensive Plan; and

WHEREAS, with much public input and with much time and effort, the Comprehensive Plan Committee recommended to the Town of Victor a draft Comprehensive Plan to replace the current 1995 Comprehensive Plan; and

WHEREAS, said draft Comprehensive Plan ("Comprehensive Plan") is now on file with the Victor Town Clerk where it is available for examination and review by the public; and

WHEREAS, in conjunction with development of the Comprehensive Plan, the Town has developed a draft Agricultural and Farmland Protection Plan, which is a component of the draft Comprehensive Plan; and

WHEREAS, said draft Agricultural Farmland Protection Plan is now on file with the Victor Town Clerk where it is available for examination and review by the public (the Comprehensive Plan and Agricultural Plan hereinafter referred to as the "Action"); and

WHEREAS, as Lead Agency pursuant to the State Environmental Quality Review Act ("SEQR"), the Town Board adopted a positive declaration with regard to the Action on June 22, 2015; and

WHEREAS, pursuant to SEQR, a draft generic environmental impact statement ("DGEIS") was duly determined to be adequate and approved for public comment on June 22, 2015, and was duly filed and published; and

WHEREAS, a thirty day public comment period on the DGEIS was duly advertised and held, ending on July 24, 2015, and all comments submitted during the public comment period were received and reviewed by the Town; and

WHEREAS, with the assistance of its staff and consultants, the Town Board has reviewed the FGEIS; now, therefore, be it



RESOLVED, that the Victor Town Board hereby directs that copies of the Final Generic Environmental Impact Statement be filed in accordance with 6 NYCRR Part 617 of the State Environmental Quality Review Act, and directs that the attached Final Environmental Impact Statement be available for public review in the Victor Town Clerk's Office, and that copies be obtained through the Victor Town Clerk's Office.
